- 5. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.
- 6. It will continue to pay Annual Fee of Rs.3000/- per annum. The schools run by Govt./Govt. Aided are granted regular affiliation and these schools have been advised to remit prescribed annual fee in CBSE by D.D./Cash in favour of Secretary, CBSE, payable at CBSE, H.Q., Preet Vihar, Delhi-110092.
